# Technical Session 1 Integrating Finance with Sustainabilty

Ms. June Cheryl Cabal-Revilla, EVP & CFO and Chief Sustainability Officer of Metro Pacific Investment Corp., discussed the MIPC sustainability journey, including the Corp.'s Sustainability Framework

with overarching purpose of *contributing to national progress and uplifting the lives of Filipinos and communities they serve.* She also shared her unique experience of travelling to the United Kingdom and meeting Prince Charles, Prince of Wales, and future King of England for Accounting for Sustainability (A4S) Roundtable last March, 2022.

# Technical Session 2 War for Talent

Ms. Ramos is currently the Managing Director & Principal Consultant Roadmaps + Beyond, Inc. During the open forum, which was facilitated by Auditor Ms. Wennie Lemen, questions on how to handle millennial



staff and applicants were raised. VP for Community Development, Ms. Cecille Carandang, introduced Ms. Mignon formally to the attendees at the start of the session.

#### **General Membership Meeting**

One of the highlights of the AWC Spotlight on Commerce & Industry was the General Membership Meeting that ensued after Technical Session 2. It kicked off with a message delivered by PICPA National Vice President for Commerce and Industry, Ms. Lolita Tang, wherein she congratulated ACPACI and PICPA-C&I for mounting an impressive technical program for the C&I AWC day. The first session in the morning entitled, "Get Ready for Sustainability Disclosures," was handled by Ms. Kristine I. Aguirre, Partner, Advisory (Risk Consultancy) Services, KPMG Philippines. She spoke about this trend across region, ESG or the Environment, Social and Governance for a sustainable future, as well as sustainable economic and business practices.

In the race to find solutions to minimize carbon emissions and devel-

instruments as well. Despite their physical limitations, they are able to make people realize that nothing is impossible in this world if only they believe in themselves and put their faith in the LORD.

MHB was founded on January 15, 1997 to provide a secure place and home for poor, abandoned, mentally challenged and abused blind girls, and to give them the education they need. At present, there are 13 blind girls at MHB. They are being taken care of and managed by the Congregation of the Sisters of Christian Charity, which was founded in Germany in 1849.

At MHB, the girls are taught to be as independent as possible and become responsible and productive citizens of the country. They are taught how to be self-sufficient, how to get oriented and mobile in any environment, do arts and crafts, and perform simple household chores.

The ACPACI group concluded the event with a nice lunch in a nearby coffee shop.
